# American Recovery & Reinvestment Act (ARRA) Overview

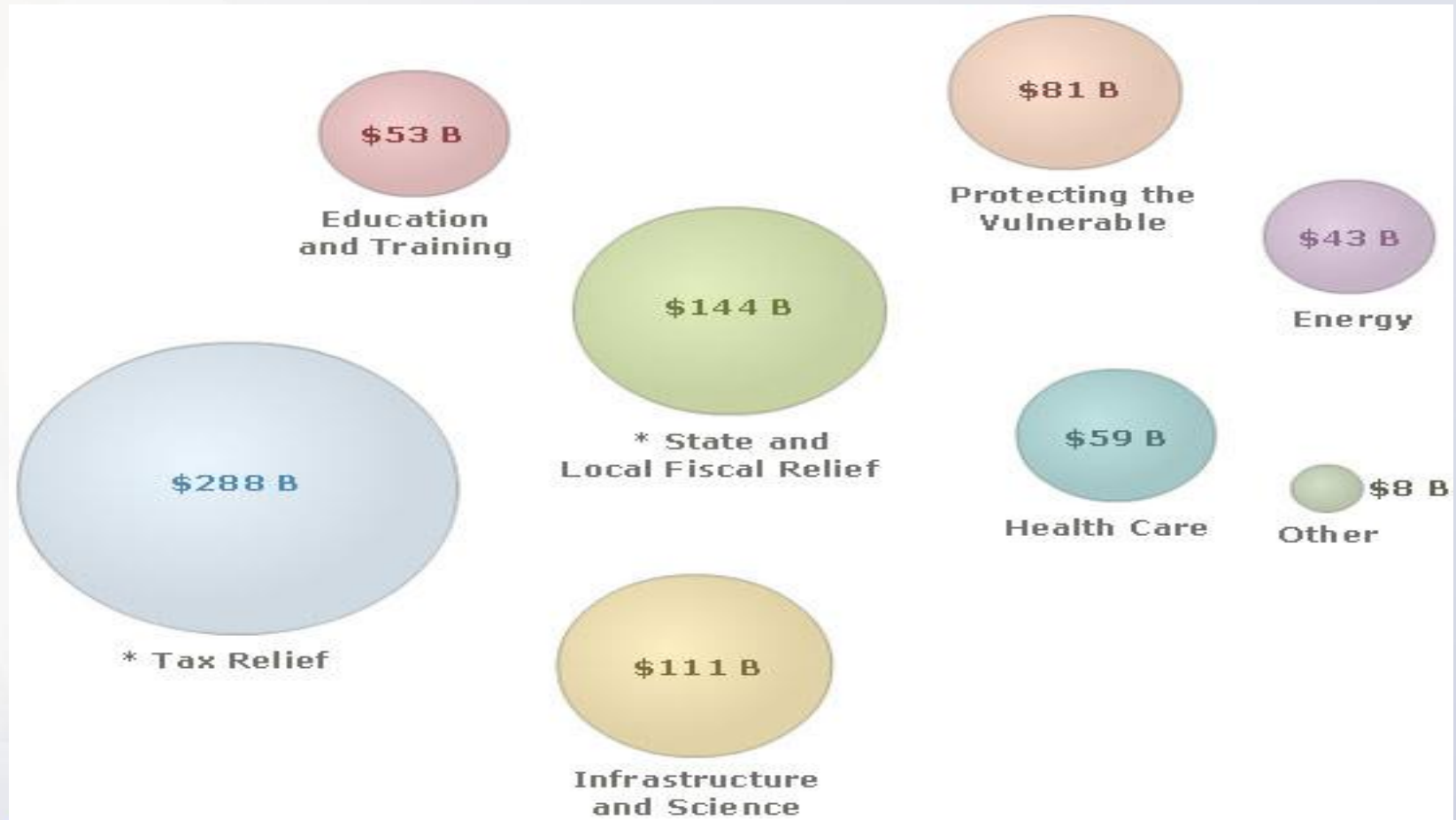
Federal Government Act signed February 17, 2009 for \$787 Billion over 28 month period

## Highlights

- Create or save 3-4 Million jobs over 28 months
- Move toward electronic health records management
- Double domestic renewable energy capacity
- Weatherization program to modernize over 1 million homes
- Increase college affordability for 7 million students
- \$150 billion in infrastructure (roads, bridges & mass transit)
- Tax & child care credits for 129 million households

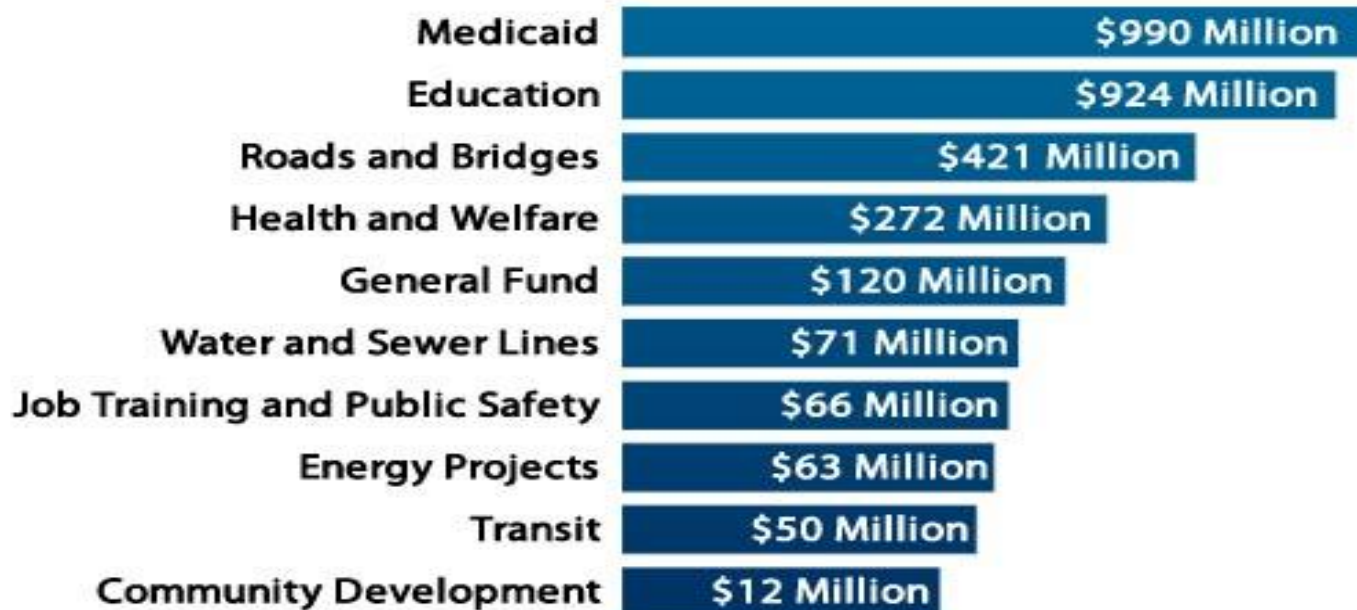

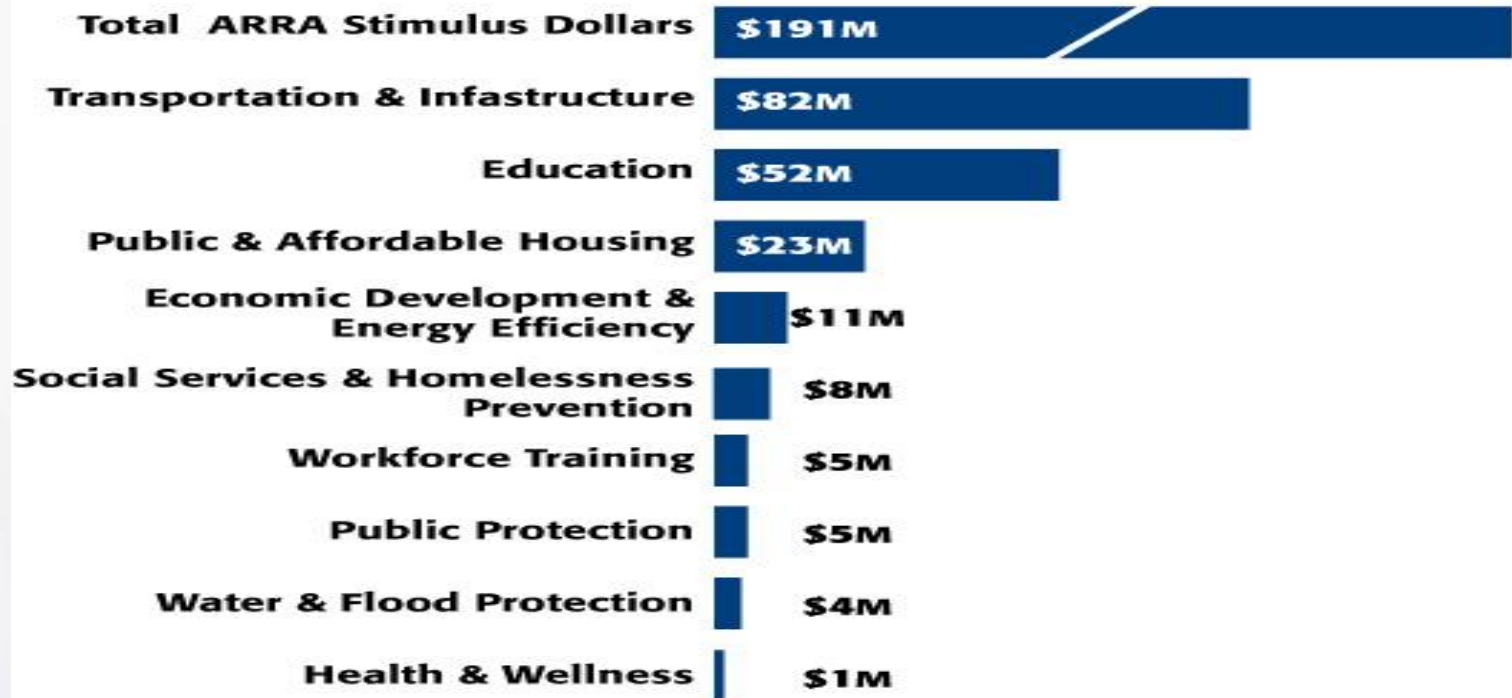
