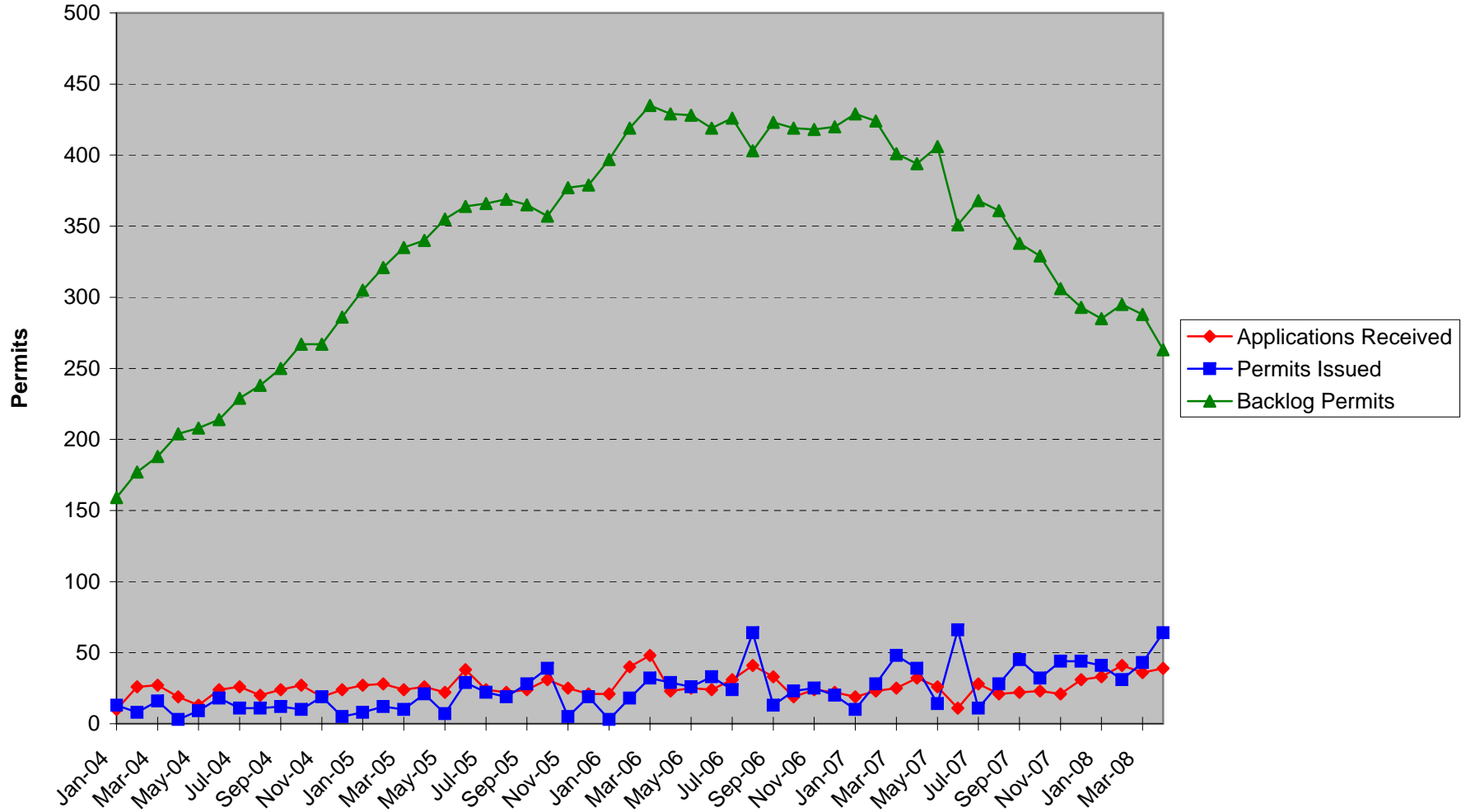

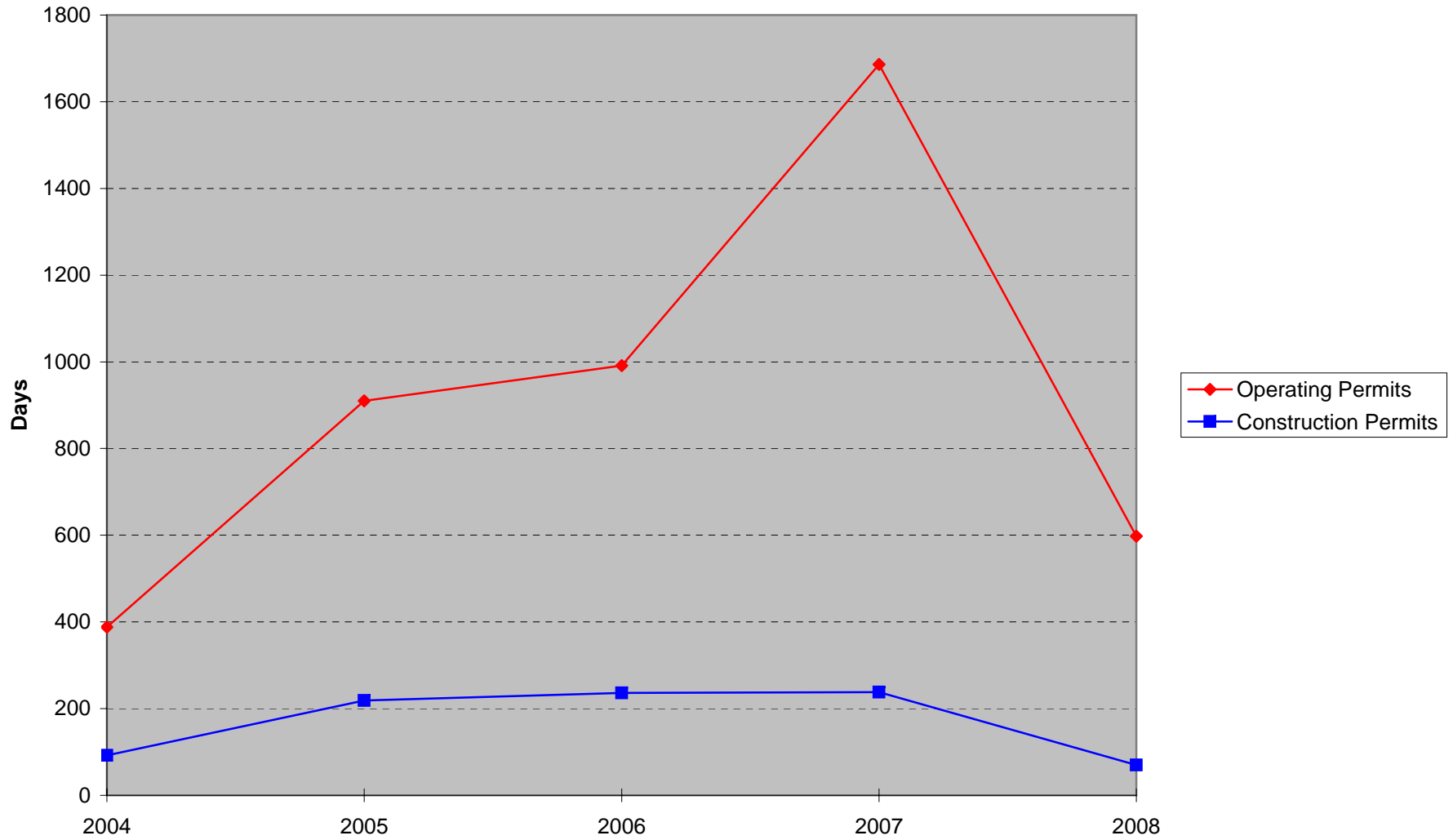

Permit Applications Over Time

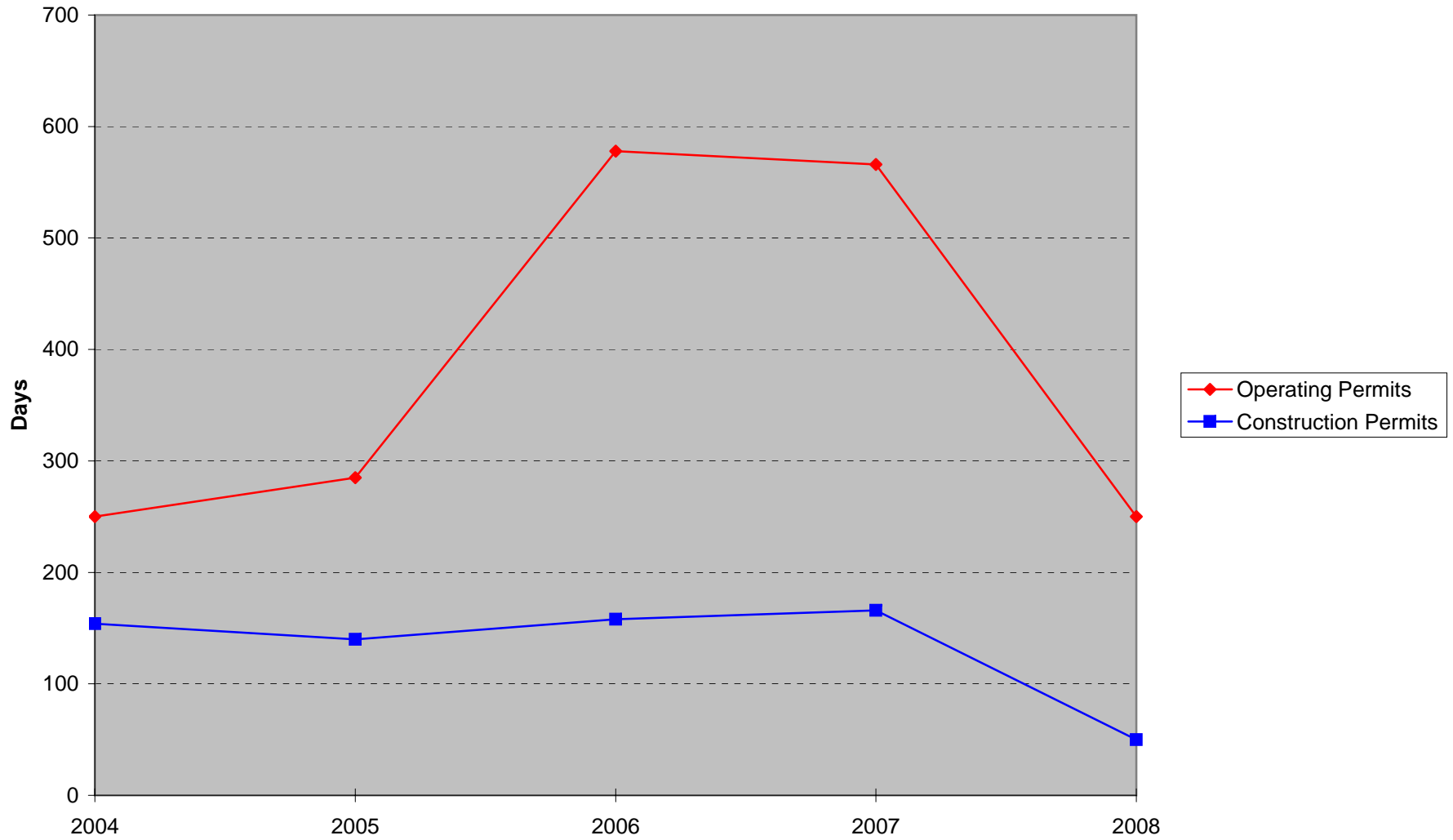
January 2004 to April 2008
