



## Brightside Adopt-A-Mile

### LOUISVILLE METRO ROADSIDE LITTER CLEANUP PROGRAM

#### AGREEMENT

between Louisville/ Jefferson County Metro Government by and through its Department of  
Neighborhoods and Brightside, hereinafter called "Louisville Metro", and  
\_\_\_\_\_ hereinafter called "Group".

#### **WITNESSETH:**

**WHEREAS,** The Parties hereto recognize the need and desirability of maintaining litter free roads and  
desire to enter into this Agreement for the purpose of permitting Group to contribute toward the effort of  
maintaining the roads and highways of Louisville Metro in a litter free condition.

**NOW,** therefore, the Parties agree as follows:

I. By the signature of its designated representative below, Group acknowledges the potential  
hazardous nature of the work to be performed in the Brightside Adopt-A-Mile program and agrees on  
behalf of its members to the following terms and conditions:

A. All participants shall sign a release and waiver in order to participate in the Brightside  
Adopt-A-Mile program. When participants under eighteen (18) years of age are performing work for the  
Brightside Adopt-A-Mile program, Group must provide adequate adult supervision.

B. Group shall be provided with a set of safety guidelines by the Louisville Metro and must  
provide to its members at least one safety training session before any member of the Group may engage in  
a clean up operation. The Group should make attendance at such safety training sessions mandatory for  
participation in this endeavor and no person should be allowed to work in this program unless such safety  
training has been provided.

C. Group agrees to adopt a section of road designated by the Louisville Metro that is a minimum of one (1) mile in length and to maintain this section of road reasonably free of litter for a period of one (1) year. The Group may pick up litter as many times as it deems necessary to keep the area reasonably free of litter, but a minimum of four times per year.

D. Group may obtain needed supplies and materials from Louisville Metro and shall return any unused supplies and materials to Louisville Metro should the Group terminate the agreement.

II. In consideration for the work of the Group detailed herein-above, Louisville Metro agrees to the following:

A. To erect a sign at the beginning of the adopted section of roadway identifying Group, to provide trash bags, safety vests, and safety literature to the Group, and to pick up all filled trash bags and heavy material. The Group is strongly encouraged to require participants to wear provided safety vests during cleanup activities.

B. Louisville Metro shall pick up large items such as appliances and tires, which are reported to it by the Groups.

C. Louisville Metro shall coordinate publicity efforts with the Group, as agreed upon.

D. If, in the judgment of Louisville Metro, the Group is not performing its duties hereunder in a satisfactory manner, Louisville Metro may terminate this Agreement upon fifteen (15) days written notice to Group. At the end of the fifteen (15) day period, signs designating the Group as being responsible for the particular section of road shall be removed.

E. Louisville Metro recognizes the Group as the adopting organization and the Group agrees to accept responsibility for the pickup of litter \_\_\_\_\_ on from \_\_\_\_\_ to \_\_\_\_\_ and for helping to promote a litter free environment in Louisville Metro for a period beginning July 1, 2009 and ending June 30, 2010.
