- (1) Bidders submitted written response to the technical specifications in response to a bid request. Bidders written response to the technical specifications were not reviewed since not the low apparent bidder.
- (2) Bid disqualified - deemed non-responsive. Bidder did not use the revised Bidder's Proposal. Revised Bidder's Proposal sent out in Addendum #2 instructing bidders to submit bids on the Revised Bidder's Proposal. Bidder changed the Bid Proposal for 0-30 days, as the Bidder's Proposal indicated a 0%. Bidder submitted a proposal in response to a bid request. Proposal not reviewed since the bid is disqualified.
- (3) Bid disqualified - deemed non-responsive. Bidder did not use the revised Bidder's Proposal. Revised Bidder's Proposal sent out in Addendum #2 instructing bidders to submit bids on the Revised Bidder's Proposal. Bidder did not acknowledge receipt of Addenda #1, #2, & #3. Bidders name was not listed on Planholders list.
- (4) Buyer inadvertently left the bid off of the bid tab. Clerical error. Information added later.
